



## **Declaration of Compliance - US TSCA PBT Substances**

This declaration certifies that all parts supplied by the Harwin, as listed in the part number list, do not contain any of the below listed Persistent, Bioaccumulative, and Toxic (PBT) substances<sup>1</sup> as restricted under US Code of Federal Regulations title 40, part 751 – "Regulation of Certain Chemical Substances and mixtures under section 6 of The Toxic Substances Control Act" (TSCA)<sup>2</sup>.

## Items do not contain:

- Phenol, Isopropylated phosphate (3:1) (PIP (3:1), CAS 68937-41-7) not present in any amount
- Decabromodiphenyl ether (DecaBDE, CAS 1163-19-5) not present in any amount
- 2,4,6-Tris(tert-butyl)phenol (2,4,6-TTBP, CAS 732-26-3) not present as an additive in oil or lubricants above 0.3% by weight
- Hexachlorobutadiene (HCBD, CAS 87-68-3) not present in any amount.
- Pentachlorothiophenol (PCTP, CAS 133-49-3) not present above 1% by weight
